



BOARD RESOLUTION NO. 579
Series of 2012

**EXTENDING THE VALIDITY OF CONTRACTORS' LICENSES ISSUED
FOR CFY 2011-2012 UNTIL 31 JULY 2012 OF CFY 2012-2013**

WHEREAS, all contractors' licenses issued by the Philippine Contractors Accreditation Board (PCAB) for CFY 2011-2012 shall expire on 30 June 2012;

WHEREAS, in accordance with other supplemental statutes and Rules/Order issued by government agencies relevant to the conduct of construction, registration with SSS, Philhealth and Pag-Ibig and completion of the Safety Seminar (COSH) and Authorized Managing Officer (AMO) Seminar have been imposed as requirements by PCAB for the issuance of the contractor's license effective CFY 2012-2013;

WHEREAS, there are contractors who are still working on the compliance with the abovestated requirements and who cannot beat the 30 June 2012 deadline for the timely filing of a complete renewal application for CFY 2012-2013;

NOW THEREFORE, for and in consideration of the foregoing premises, the Board RESOLVES as it is hereby RESOLVED to extend the validity period of contractors' licenses issued for CFY 2011-2012 until 31 July 2012 of CFY 2012-2013 subject to the following terms and conditions:


1. The extension of license validity until 31 July 2012 shall not be further extendible.
2. The Additional License Fee (ALF) shall not be imposed upon those filing their renewal applications within the period 01 July 2012-31 July 2012.
3. A contractor whose license has not yet been renewed shall be allowed to undertake construction activity until 31 July 2012 upon presentation of his/its contractor's license for CFY 2011-2012 to the pertinent project owner provided the license has not been suspended/revoked or recalled by the Board for any reason whatsoever.
4. Similarly, a license which validity has been extended until 31 July 2012 shall be qualified to enter into Joint Venture (JV)/Consortium Agreements and the respective JV/Consortium application may be acted upon by the Board accordingly.
5. Contractors whose renewal applications for CFY 2012-2013 have been acted upon and whose licenses for the said period had been issued shall not be covered by this Resolution.
